

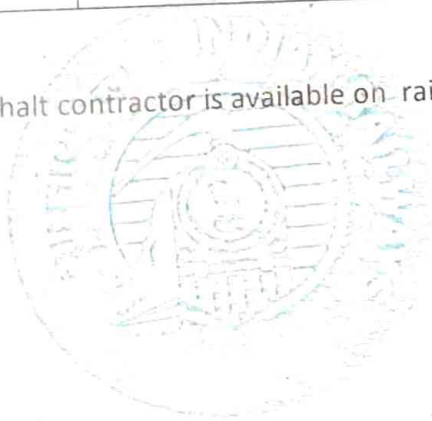

After the allotment of contract the selected person will have to deposit Demand Draft of Rs. 2000/- in favour of Sr.Divisional Finance Manager Ambala. The applicant should be at least 10" standard passed and should have working knowledge of simple English. Along with application, the applicant should submit attested photo copy of Educational Certificates and attested Photo-Copies local Residential certificate (issued by DM/ADM of the District) or Voter identity card or Aadhaar card . The applicant is also required to submit original Character Certificate (issued by SDM/DM or police Authorities of the District) & Medical Fitness certificate issued by Govt. Hospital showing that he/she is fit for the active service and free from any communicable diseases along with the application. The application should reach to the office of Sr. Divisional Commercial Manager office on 29/01/26 between 10:00 hrs to 15:00 hrs. The period of contract will be five years, The Divisional Railway Manager, Northern Railway, Ambala Cantt reserves the right to cancel any or all the applications at his discretion and his decision in this regard will be final and binding on the applicants.

NOTE :- 1. This advertisement is for the allotment of the halt contract and not for any Govt service. Only Those persons should apply for the above mentioned halt contract who are permanent residents of the place where the halt station is located.

The Details of Commission To be paid to halt Contractor is as under:-

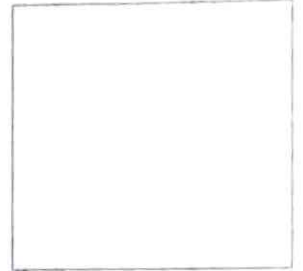
S.No	Sales turnover in Rs	Commission Payable
1	1-15,000	15%
2	15,001-50,000	12%
3	50,001-1,00,000	9%
4	1,00,001-2,00,000	6%
5	2,00,001 and above	3%

The minimum commission payable to the halt contractor would be Rs 1000/- per month for halts having stoppage of upto 2 pairs of trains and Rs. 1500/- per month for halt having stoppage of more than 2 pairs of trains.
